d. Setbacks

1. Except as otherwise provided in subsections (d)(2) through (8) of this section, accessory structures shall be located between the rear property line and the principal building and shall be set back at least five feet from the rear and side property lines and at least ten feet from the principal building.
2. Screened accessory structures one hundred twenty square feet or less in size may have a zero setback.
3. Accessory structures with a height greater than the height of an opaque perimeter fence but ten feet in height or less shall be set back from property lines at least five feet.
4. Accessory structures more than ten feet in height shall be set back from property lines five feet plus one foot for every foot of height over ten feet (step back).
5. For corner lots, accessory structures shall be set back the required side street setback distance.
6. Storage accessory structures used as a garage and located on an alley shall be set back not less than four feet from the rear property line and are not subject to step back requirements in subsection (d)(4) of this section.
7. Shade accessory structures other than tents may be located between the side setback line and the principal building and when located as such shall comply with the setback requirements for the principal building.
8. Guesthouses may be located in the area between the side yard setback line and the principal building and between the front yard setback line and the principal building and when located as such shall comply with the setback requirements for the principal building.
9. Rear setbacks on properties with side yard view fences shall be equal to or greater than the length of the view fence portion of the side yard wall.

e. Height Accessory structures shall not exceed the height of the principal building or fifteen feet in height, whichever is less.

f. Lot Coverage; Size No accessory structure or combination of structures shall occupy more than twenty-five percent of the area lying between the rear of the principal building and the rear property line or exceed five hundred square feet in area, whichever is less. No accessory structure shall cause 80 (Litchfield Park Zoning Supp. No. 14, 9-13)31.04 the maximum lot coverage applicable to the lot to be exceeded.

In Phase I, single family residential lots that back up against Tracts H, S or T as referenced on the plat and have a minimum of 8500 square feet, a minimum depth of 100' and an average minimum width of 70' **may have accessory buildings located in the rear with a zero foot rear yard setback**. In such cases, the minimum side yard setback for the accessory building shall be at least five feet. In subsequent phases, lots meeting the above minimum size, depth and width criteria may have accessory buildings located in the rear yard setback only upon approval of additional drainage way, pathways or park tracts of similar size as Tracts H, S and T.

 - (3) On any other corner lot, an accessory building shall not be located closer than ten (10) feet from the property line.
 - (4) On a lot in the AG District, an accessory building shall not be located closer than twenty (20) feet to rear and side property lines.
 - (5) Where permitted, guest houses shall adhere to the primary building setbacks for the zoning district in which the guest house is to be located.
- (d) In all zoning districts except for Single-Family Residential Districts, covered parking canopies may be located within required side and rear setbacks unless a landscape buffer is required by [article 12](#) of this ordinance.
- (e) No building that is accessory to any residential building shall be erected to a height greater than fifteen (15) feet, except for an ADU per section [28-33](#) and on a residential lot in the AG District, a shelter for the keeping of animals, silos or other similar structures customarily used in association with an agricultural use may be erected to the maximum height allowable for the main building in that district.

All accessory buildings shall count towards the maximum allowable lot coverage on a given lot.

General Standards. All accessory uses and structures shall comply with the following general standards:

A. Compliance with this Development Code.

1. All accessory uses and structures shall be subject to the dimensional requirements of [Article 4, *Dimensional Standards*](#). In the case of any conflict between the accessory use/structure standards of this section and any other requirement of this Development Code, the more restrictive standards shall control.

2. Accessory uses shall comply with all standards of this Development Code applicable to the principal use with which they are associated. Parking requirements shall be met for both the principal use and any accessory use.

B. Location. The accessory use or structure shall be conducted and/or located on the same lot(s) as the principal use and to the rear of the front setback line, unless otherwise approved by the Director.

Open accessory structures with no walls such as trellises, pergolas, and patio covers shall have no separation from the site's principal structure. All other accessory structures shall be separated eight feet from the site's principal structure.

When located to the rear of the primary structure, accessory buildings need not comply with the side or rear setback lines applicable to the primary structure provided that the accessory building is not located closer than three feet from any property line. This side and rear yard setback shall be five feet for accessory structures which exceed ten feet in height. Accessory structures with vehicle entrances which directly face an alley shall be setback at least ten feet from the property line along the alley.

The maximum height of any accessory structure shall not exceed the height of the lot's primary structure

Architectural Character. Accessory structures with a gross floor area of 225 square feet or more shall be compatible to and complimentary with the associated primary structure in terms of building materials and architectural style.

b. Rear **accessory buildings** are defined as **buildings** located in the rear half of the **lot**. Their **use** is limited to standard **uses** that are allowed in the main **building**, with the exception of the kitchen.

(a) One (1) foot setback shall be required on all sides of an **accessory building** for each one (1) foot in height (to the peak of the building) above the **lot** perimeter fence or **wall**, which shall not exceed six (6) feet in height.

2. No **building**, which is accessory to any residential **building**, shall be erected to a height greater than twelve (12) feet unless it is within the same setback requirements as the main **building**, but may not exceed the height of the main **building**.

3. All **accessory buildings** designed or used for sleeping or living purposes (**Casitas**) shall be within the same setback requirements as that of the main building.

4. No Casitas shall be constructed on any lot or parcel with an Accessory Dwelling Unit.

2. Detached **accessory buildings** shall be permanently affixed to the ground by anchoring or slab attachment.

3. No **accessory buildings** shall occupy more than twenty five (25) percent of the area lying between the rear of the main **building** and the rear property line.

1. *Maximum Height.* The height of an accessory building shall not exceed twenty (20) feet in height except in the R1-18 and R1-35 zoning districts OR other zoning districts with minimum lot sizes 18,000 square feet or greater. Where a property is located in a zoning district with a minimum lot size of 18,000 square feet or greater, all accessory buildings shall have a maximum height of twenty-five (25) feet.
2. No accessory building shall be located in any front yard.

A detached accessory building, less than eight (8) feet in height and with a total floor area or projected roof area which does not exceed two hundred (200) square feet, may be located in the required side or rear yard adjacent to the property line provided the structure is not served by utilities and is screened from public view.
4. A detached accessory building between eight (8) and nine (9) feet in height or greater than two hundred (200) square feet in area, may be located a minimum of three (3) feet from the side or rear property line provided the structure is screened from public view.
5. Accessory buildings exceeding nine (9) feet in height and/or three hundred (300) square feet in area shall meet the required setbacks of the respective zoning district. Accessory buildings exceeding nine (9) feet in height and located along property lines abutting golf courses, water tanks, well sites, utility substations, water treatment plants and similar land uses as determined by the Planning Manager shall be allowed a three (3) foot side or rear setback provided that the height of the structure shall not exceed the height of the principal building.
6. Accessory buildings nine (9) feet in height or greater OR three hundred (300) square feet or greater shall conform to the City of Peoria Design Review Manual.

d. Setbacks

1. Except as otherwise provided in subsections (d)(2) through (8) of this section, accessory structures shall be located between the rear property line and the principal building and shall be set back at least five feet from the rear and side property lines and at least ten feet from the principal building.
2. Screened accessory structures one hundred twenty square feet or less in size may have a zero setback.
3. Accessory structures with a height greater than the height of an opaque perimeter fence but ten feet in height or less shall be set back from property lines at least five feet.
4. Accessory structures more than ten feet in height shall be set back from property lines five feet plus one foot for every foot of height over ten feet (step back).
5. For corner lots, accessory structures shall be set back the required side street setback distance.
6. Storage accessory structures used as a garage and located on an alley shall be set back not less than four feet from the rear property line and are not subject to step back requirements in subsection (d)(4) of this section.
7. Shade accessory structures other than tents may be located between the side setback line and the principal building and when located as such shall comply with the setback requirements for the principal building.
8. Guesthouses may be located in the area between the side yard setback line and the principal building and between the front yard setback line and the principal building and when located as such shall comply with the setback requirements for the principal building.
9. Rear setbacks on properties with side yard view fences shall be equal to or greater than the length of the view fence portion of the side yard wall.

e. Height Accessory structures shall not exceed the height of the principal building or fifteen feet in height, whichever is less.

f. Lot Coverage; Size No accessory structure or combination of structures shall occupy more than twenty-five percent of the area lying between the rear of the principal building and the rear property line or exceed five hundred square feet in area, whichever is less. No accessory structure shall cause 80 (Litchfield Park Zoning Supp. No. 14, 9-13)31.04 the maximum lot coverage applicable to the lot to be exceeded.

In Phase I, single family residential lots that back up against Tracts H, S or T as referenced on the plat and have a minimum of 8500 square feet, a minimum depth of 100' and an average minimum width of 70' **may have accessory buildings located in the rear with a zero foot rear yard setback**. In such cases, the minimum side yard setback for the accessory building shall be at least five feet. In subsequent phases, lots meeting the above minimum size, depth and width criteria may have accessory buildings located in the rear yard setback only upon approval of additional drainage way, pathways or park tracts of similar size as Tracts H, S and T.

In all Single-family residential districts, detached accessory buildings shall conform to the following restrictions concerning their locations on a lot.

- (a) Detached accessory buildings shall not be permitted within a front yard, as defined in [article 1](#) of this Zoning Ordinance.
- (b) Any detached accessory building not located in the rear one-half (½) of a lot shall maintain such yards as are required for a dwelling unit on the same lot except for an accessory dwelling unit (ADU) per section [28-33](#).
- (c) Detached accessory buildings placed in the rear one-half (½) of a lot may encroach into the required rear and side yard setbacks subject to the following conditions, except as otherwise provided for ADUS per section [28-33](#):
 - (1) On a through lot, an accessory building shall not be located closer to the rear property line than the distance required for front yard setback.
 - (2) On a corner lot contiguous to a key lot, no detached accessory building shall be erected or altered so as to come closer to a street side of the corner lot than the front yard required on the key lot. In no instance, however, shall a setback greater than twenty-five (25) feet be required.
 - (3) On any other corner lot, an accessory building shall not be located closer than ten (10) feet from the property line.
 - (4) On a lot in the AG District, an accessory building shall not be located closer than twenty (20) feet to rear and side property lines.
 - (5) Where permitted, guest houses shall adhere to the primary building setbacks for the zoning district in which the guest house is to be located.
- (d) In all zoning districts except for Single-Family Residential Districts, covered parking canopies may be located within required side and rear setbacks unless a landscape buffer is required by [article 12](#) of this ordinance.
- (e) No building that is accessory to any residential building shall be erected to a height greater than fifteen (15) feet, except for an ADU per section [28-33](#) and on a residential lot in the AG District, a shelter for the keeping of animals, silos or other similar structures customarily used in association with an agricultural use may be erected to the maximum height allowable for the main building in that district.

All accessory buildings shall count towards the maximum allowable lot coverage on a given lot.

General Standards. All accessory uses and structures shall comply with the following general standards:

A. Compliance with this Development Code.

1. All accessory uses and structures shall be subject to the dimensional requirements of [Article 4, Dimensional Standards](#). In the case of any conflict between the accessory use/structure standards of this section and any other requirement of this Development Code, the more restrictive standards shall control.

2. Accessory uses shall comply with all standards of this Development Code applicable to the principal use with which they are associated. Parking requirements shall be met for both the principal use and any accessory use.

B. Location. The accessory use or structure shall be conducted and/or located on the same lot(s) as the principal use and to the rear of the front setback line, unless otherwise approved by the Director.

Open accessory structures with no walls such as trellises, pergolas, and patio covers shall have no separation from the site's principal structure. All other accessory structures shall be separated eight feet from the site's principal structure.

When located to the rear of the primary structure, accessory buildings need not comply with the side or rear setback lines applicable to the primary structure provided that the accessory building is not located closer than three feet from any property line. This side and rear yard setback shall be five feet for accessory structures which exceed ten feet in height. Accessory structures with vehicle entrances which directly face an alley shall be setback at least ten feet from the property line along the alley.

The maximum height of any accessory structure shall not exceed the height of the lot's primary structure

Architectural Character. Accessory structures with a gross floor area of 225 square feet or more shall be compatible to and complimentary with the associated primary structure in terms of building materials and architectural style.

b. Rear **accessory buildings** are defined as **buildings** located in the rear half of the **lot**. Their **use** is limited to standard **uses** that are allowed in the main **building**, with the exception of the kitchen.

1. Setback requirements for rear **accessory buildings** are modified to allow encroachment into the required side and rear **yard** except for the following:

(a) One (1) foot setback shall be required on all sides of an **accessory building** for each one (1) foot in height (to the peak of the building) above the **lot** perimeter fence or **wall**, which shall not exceed six (6) feet in height.

(b) *Through lot*. The **accessory building** shall not be located closer to the rear property lines than the distance required for front **yard** setback.

(c) *Corner lot*. The **accessory building** shall not be located closer to the street or side property line than the setback required for the main building.

(d) *Corner lot contiguous to key lot*. No detached rear **accessory building** shall be located closer to the street side of a **corner lot** than the front **yard** required on the **key lot**, except such setback need not be greater than one-half (1/2) the width of the **corner lot**.

2. No **building**, which is accessory to any residential **building**, shall be erected to a height greater than twelve (12) feet unless it is within the same setback requirements as the main **building**, but may not exceed the height of the main **building**.

3. All **accessory buildings** designed or used for sleeping or living purposes (**Casitas**) shall be within the same setback requirements as that of the main building.

4. No Casitas shall be constructed on any lot or parcel with an Accessory Dwelling Unit.

2. Detached **accessory buildings** shall be permanently affixed to the ground by anchoring or slab attachment.

3. No **accessory buildings** shall occupy more than twenty five (25) percent of the area lying between the rear of the main **building** and the rear property line.

C. Development Standards.

1. *Maximum Height.* The height of an accessory building shall not exceed twenty (20) feet in height except in the R1-18 and R1-35 zoning districts OR other zoning districts with minimum lot sizes 18,000 square feet or greater. Where a property is located in a zoning district with a minimum lot size of 18,000 square feet or greater, all accessory buildings shall have a maximum height of twenty-five (25) feet.
2. No accessory building shall be located in any front yard.
3. A detached accessory building, less than eight (8) feet in height and with a total floor area or projected roof area which does not exceed two hundred (200) square feet, may be located in the required side or rear yard adjacent to the property line provided the structure is not served by utilities and is screened from public view.
4. A detached accessory building between eight (8) and nine (9) feet in height or greater than two hundred (200) square feet in area, may be located a minimum of three (3) feet from the side or rear property line provided the structure is screened from public view.
5. Accessory buildings exceeding nine (9) feet in height and/or three hundred (300) square feet in area shall meet the required setbacks of the respective zoning district. Accessory buildings exceeding nine (9) feet in height and located along property lines abutting golf courses, water tanks, well sites, utility substations, water treatment plants and similar land uses as determined by the Planning Manager shall be allowed a three (3) foot side or rear setback provided that the height of the structure shall not exceed the height of the principal building.
6. Accessory buildings nine (9) feet in height or greater OR three hundred (300) square feet or greater shall conform to the City of Peoria Design Review Manual.
